- 1. Call to Order @7:30pm.
- 2. Roll call all present
- 3. M. Evans made a motion to approve the agenda, Krueger second, motion carried.
- 4. Public participation for agenda items heard.
- 5. Minutes from the July 17, 2014 meeting were read. Wood made a motion to approve the minutes, Krueger second, motion carried.
- 6. Benzie County Planning Commission Update. Susan Zenker explained that the BCPC was working to update their Master Plan in coordination with NWMCOG (Northwest Michigan Council of Governments) and the Parks and Recreation group of Benzie County.

7. Unfinished business

1. Allowable uses in the Rural & Commercial districts. The commission talked about the need to spend time reviewing neighboring ordinances and see what is liked or not. Tamara from Beckett & Raeder suggested that the PC review Arcadia and Pleasanton township because of the similar agriculture districts. Other communities to review may be Antrim County or other surrounding counties. Beckett & Raeder is working on writing four model ordinances and these models may help us with this decision or at least give us some resources.

7. New Business

- 1. Lakes to Land Update Betsy gave this update on the progress of Lakes to Land. First, a zoning ordinance Audit is being conducted and once this is finished funding will be sought for new ordinance. Secondly, all communities except Arcadia have adopted a Master Plan. Third, Rob Carson presented about Manistee's Recreation Plan which does include some L2L communities. This plan will include some very detailed online maps. Finally, a variety of MSU extension classes will be offered in the area in September and October. Topics will include zoning ordinances, blight and a Place Making workshop.

However, should the planning commissioners individually or collectively wish to address the comments of the speaker(s), at the approval of the Chair, responses may be made.
