## LAKES TO LAND REGIONAL INITIATIVE BEGINS

**MANISTEE AND BENZIE COUNTIES** - The largest intergovernmental collaborative effort of its kind in Michigan has begun, the Lakes to Land Regional Initiative, where eight townships and a city in Manistee and Benzie counties will work in unison to develop master plans, recreational plans and a collaborative implementation strategy.

The Initiative is funded under a \$157,000 grant from the Michigan Economic Vitality Incentive Program administered by the Michigan Department of Treasury and a \$65,000 grant from the CS Mott Foundation.

Participating local governments include Onekama, Arcadia, Pleasanton and Bear Lake Townships in Manistee County; Blaine, Gilmore, Joyfield and Crystal Lake Townships in Benzie County and the City of Frankfort in Benzie County. Onekama Township and the City of Frankfort have recently completed master plans and are participating only in the portion of the project to develop a collaborative implementation strategy.

The project is guided by a leadership team consisting of at least two representatives from each of the participating local governments. Leadership team members are responsible for guiding the work of the consultant they selected, Beckett & Raeder, for keeping their planning commissions, boards and other entities informed and involved, for encouraging participation by all interests in the development of the plans and strategies and for providing continuity between planning and implementation phases.

Additional governmental units may choose to join the project until June.

"The master plans will provide all townships with an opportunity to involve all interests in defining a course for their future," said Brad Hopwood, who chairs the leadership team for the project. The recreation plans will help us more fully understand how we can harness the full potential of resources in our respective townships. And by working together in unison, the governmental units will identify collaborative opportunities involving two or more of the participating jurisdictions that are of mutual benefit. I am particularly interested in defining how Arcadia Township can work with our neighbors in establishing corridors for economic development, recreation, tourism, non-motorized transportation, agriculture and other areas of focus that make sense as well as looking at opportunities for service sharing to reduce government costs."

Two information meetings will be held on May 23 and 24, 2012 to introduce the purpose, goals and objectives, opportunities for public participation, and schedule for the project.

The May 23 meeting will be held from 7-8:30 p.m. at Bear Lake High School Gym.

The May 24 meeting will be held from 7-8:30 p.m. at the Frankfort Elementary School Gym.

Community Visioning sessions will kick off the master plan development process in each of the participating townships during the week of June 14. Dates, locations and times will be announced.
