# **Executive Summary**

This plan was prepared with the Benzie County Parks and Recreation Commission (PRC). The PRC is the governing body of most publicly funded recreational and cultural entities in Benzie County. This plan was created to provide a detailed description of the available parks, recreational facilities, and cultural entities in Benzie County. There is also a thorough description of the PRC based on the community they operate in, their administrative structure, their finances, and other agencies they work with. Additionally, it provides a formal vision of the goals, objectives, and action strategies of the PRC for the next five years. This plan has been prepared according to the 2006 version of the *Guidelines for the Development of Community Park, Recreation, Open Space, and Greenway Plans* published by the Michigan Department of Natural Resources.

This plan is important to all residents of Benzie County for several reasons. First, it provides the only comprehensive inventory of parks, recreational facilities, and cultural entities in Benzie County. Second, it is a requirement of the Michigan Department of Natural Resources to apply for DNR grant funding. Since 1985, Benzie County has received over 3 million dollars in DNR grant monies for the development of different recreational facilities and the preservation of recreational properties. This plan also provides Benzie County residents with a means of sharing their opinions on recreational and cultural matters in the County.

In order to create this plan, public input was gathered at several points in the process. A mailed survey was distributed to a random sample of 2000 Benzie County Residents. There was also a public input session that was open to any resident of the County that wanted to voice their opinions or concerns. In addition, public input was gathered from the previous Recreation Plans, as well as the Benzie County 2020 Comprehensive Development Plan. As an appointed commission governing the recreational and cultural resources of Benzie County, the PRC realizes the value of public input in the planning process.

This version of the plan was prepared as a revision of the existing 1992, 1997, and 2002 Benzie County Recreation Master Plans. However, an important part of this plan that was not present previously is an emphasis on cultural entities/activities as well as on recreation. The PRC believes that cultural activities and pursuits in Benzie County frequently overlap with recreational activities and pursuits. Therefore, it is in the best interest of the residents of Benzie County, as well as visitors from outside of the County, for the PRC to plan for both their cultural and recreational needs.



# **Community Description**

# This Master Plan is for Benzie County in the State of Michigan.

Benzie County includes twelve townships, six villages, one city, and extensive State and Federal lands (See the map on page 46). This master plan addresses the maintenance and sustainability of existing parklands and cultural resources, as well as the acquisition and development of new ones. It addresses the need for greater partnerships between local jurisdictions and non-governmental agencies within Benzie County and the region, and focuses on the recreational and cultural programming needs of citizens and visitors to Benzie County.

Because of the wealth of environmental resources in Benzie County, the Benzie County Parks and Recreation Commission is committed to environmental preservation in all of their activities.

Benzie County is relatively small in area and population, but large in its natural resources. It is the smallest county in Michigan with only 316 square miles (Benzie County Government, 2008). The County has extensive shoreline on Lake Michigan, numerous inland lakes and streams, and includes parts of the Pere Marquette State Forest, as well as the Sleeping Bear Dunes National Lakeshore. There are great recreational resources available, but few financial or institutional resources to adequately incorporate these resources into the recreational and cultural infrastructure of the County and communities within the County. Therefore, developing existing parklands and acquiring new ones can be difficult and requires intergovernmental and non-governmental cooperation and good planning.



#### **Administrative Structure**

The Benzie County Parks and Recreation Commission is comprised of ten members. They have a mission statement that reads:

"To provide quality recreational opportunities for all residents and visitors for the County. To protect and maximize the existing resources of the County. To foster stewardship and partnership for the expansion of recreational resources for future community benefit."

The organizational chart of the Parks and Recreation Commission and how it fits into the county government is as follows:



The Benzie County Parks and Recreation Commission was established under the enabling legislation of PA 261 of 1965 (MDNR, 2006). This act "authorizes the creation and prescribes the powers and duties of county and regional parks and recreation commissions; and prescribes the powers and duties of county boards of commissioners with respect to county and regional parks and recreation commissions" (Michigan Legislature).

The Benzie County Parks and Recreation Commission, the Betsie Valley Trailway Management Council, and the non-profit Friends of the Point Betsie Lighthouse are the only three county administrative entities that govern recreation and cultural opportunities in the county. The Betsie Valley Trailway Management Council oversees the Betsie Valley Trail. The Friends of the Point Betsie Lighthouse manage the Point Betsie Lighthouse. The Parks and Recreation Commission assumes all other responsibilities that pertain to parks, recreation, and culture. Unlike other counties, there is no parks and recreation department. There also are no paid staff members of the Parks and Recreation

Commission, the Friends of the Point Betsie Lighthouse, or the Betsie Valley Trailway Management Council. Volunteers are used occasionally, but most services must be contracted out.

Funding for the Benzie County Parks and Recreation Commission operational budget comes directly from the County General Fund. Some local grants and DNR Recreation Grants have been received in the past, but these cover capital projects and maintenance of the Betsie Valley Trail. Funding is always a challenge for the Parks and Recreation Commission. A possible recreation tax is an option in the future to help raise funds for operations and capital projects. The following budgets are the 2007-2008 adopted budget, the 2008-2009 requested budget, and the 2008-2009 adopted budget.

# **Collaborating Organizations**

The Benzie County Parks and Recreation Commission works closely with several different government agencies and non-profit organizations. The following list identifies some of those agencies and the nature of their relationships with the Benzie County Parks and Recreation Commission:

**Benzie County Sheriff Department** - They provide marine and snowmobile patrols of trails, parks, forests, and waterways.

**Benzie County Planning Department** - The department has provided staffing as needed in the development of this plan. The County Planner works very closely with the Parks and Recreation Commission in the implementation of their goals and objectives.

**Benzie County Planning Commission** - They assisted in the public process to develop this plan by co-hosting the public input session. It is the intent of the BCPC to adopt this plan as the Recreation Section of the updated Benzie County Master Plan.

**Benzie County Road Commission** - They are currently working closely with the Parks and Recreation Commission on the Lake Michigan Drive Road-end project, and have made a commitment to keep all road-ends open to the public in Benzie County.

**Grand Traverse Regional Land Conservancy** - The Parks and Recreation Commission oversees the Railroad Point Natural Area. Lands owned by the Conservancy are open to recreational use within Benzie County.

**Betsie Valley Trailway Management Council** - The Parks and Recreation Commission maintains a working relationship with the Betsie Valley Trailway Management Council.

**Grand Traverse Regional Community Foundation** - They hold the Railroad Point Natural Area Endowment Fund and the Point Betsie Lighthouse Fund for Benzie County. The GTRCF has a fiduciary relationship with Benzie County and the Parks and Recreation Commission that benefits the Railroad Point Natural Area and the Point Betsie Lighthouse.

**Grand Traverse Band of Ottawa and Chippewa Indians** - They have contributed grant money for the development of the Lake Michigan Drive Boat Ramp reconstruction project. They have also helped local schools with their sports programs and the Benzonia Township Park. The tribe contributes grant money through their 2% funds.

**Benzie Conservation District** - They maintain a working relationship with the Parks and Recreation Commission, and have been involved in the forestry management projects.

**Youth Advisory Council** - They sponsor teen recreation events in the county with the youth services endowment fund held by the GTRCF.

**Conservation Resource Alliance** - They maintain a working relationship with the Parks and Recreation Commission, and have been involved in watershed management and River Care projects.

**National Park Service** - They maintain a working relationship with the Parks and Recreation Commission, and have been directly involved, as adjacent property owners, with the Lake Michigan Drive Road-end Project. They also participate in county planning.

**Michigan State University Extension -** They work with the Parks and Recreation Commission on recreation planning, and participated in the development of this plan. They also operate recreational programs and 4H.

**TART Trail** - They are working with the Parks and Recreation Commission to connect the TART Trail to the Betsie Valley Trail.

**MDNR** - They maintain a working relationship with the Parks and Recreation Commission, and are currently involved with the Parks and Recreation commission on a trail project and two public boating access projects in Benzie County. The MDNR oversees the Natural Wild and Scenic River designation on the Betsie River.

**Council of Governments** - They maintain a working relationship with the Parks and Recreation Commission, and are currently taking a leadership role with MDOT in the NW Michigan Regional Non-Motorized Transportation Plan.

**Cultural Organizations Collaborative** - Comprised of cultural organizations in Benzie County i.e., Mills Community House Association, Crystal Lake Art Association, Friends of the Point Betsie Lighthouse, library friends groups, historical societies, that maintain a working relationship with the Parks and Recreation Commission with regard to planning, programming, and creation of the Benzie County Parks and Recreation web page.

**School Districts** - They maintain a working relationship with the Parks and Recreation Commission.

**Local Service Clubs and Interest Groups** - They maintain a working relationship with the Parks and Recreation Commission.

# **Recreation and Cultural Inventory for Benzie County**

This chapter provides a thorough inventory of recreational and cultural entities within Benzie County. The County has extensive State and Federal lands, and many outstanding natural and built resources, with many possible recreational and cultural uses.

The following inventories were conducted following a three-step process. First, the inventories from the 1997 and 2002 Benzie County Recreation Plans were reviewed. Second, local officials from the specific townships, villages, and cities, as well as certain Benzie County residents were contacted to determine what updates and/or changes were needed for the existing inventories. The final method was to review the feedback from local officials and County residents with the Benzie County Parks and Recreation Commission and Planning Department to ensure the accuracy of the inventories.

Following all of the individual jurisdiction's inventory pages (township, city, village, or National Park) are maps with the exact location of each recreational and cultural entity. There is also a map of the entire county with only major roads, as well as a County Map with all of the State, Federal, and Conservation lands indicated. Inventory page listings are formatted with the name of the entity first, then the organization in charge of the entity in parentheses, followed by a description of the entity. The final part of each listing is the Americans with Disabilities Act (ADA) Assessment in italics.

All recreational or cultural entities that are operated by any agency other than private establishments were assessed according to ADA standards. These standards were gathered by consulting ADA Guidelines for Buildings and Facilities; Final Rule, ADA Accessibility Guidelines for Buildings and Facilities; Architectural Barriers Act, and ADA Accessibility Guidelines; Recreation and Facilities; Supplemental Notice of Proposed Rulemaking (Architectural and Transportation Barriers Compliance Board, 2002). The grading scale for accessibility used in this document is the DNR proposed grading scale from DNR Guidelines for the Development of Community Park, Recreation, Open Space and Greenway Plans (MDNR, 2006)

#### **ADA Accessibility Scale**

- 1 None of the facilities/parks areas meet accessibility guidelines.
- 2 Some of the facilities/parks areas meet accessibility guidelines.
- 3 Most of the facilities/parks areas meet accessibility guidelines.
- 4 The entire facility/park meets accessibility guidelines.
- 5 The entire facility/park was developed or renovated using the principles of universal design.

All parks in this inventory are classified as miniature parks, neighborhood parks, or community parks. Their descriptions also include their size, when available, and their estimated service area.

The final section of this chapter is a complete listing of DNR grants that the Benzie County Parks and Recreation Commission has received, and how the grant funds were used.

# Almira Township

The park has a picnic area, 4 baseball diamonds, a soccer field, a volleyball court, parking, water, lighting, a storage building, 3 restrooms, and a pavilion with power. A nine-hole disc-golf course has been added.

# 2. **Timberline Campground** (Private)

189 campsites with electric, water, sewer hookups, RV sanitary dump station, pool, showers, and RV storage.

# 3. Benzie Central Junior and Senior High School Complex (Benzie County

Central School District) – Outdoor football and track stadium, baseball diamond, softball diamond, soccer field, gymnasium, basketball court, auditorium, classrooms, and meeting rooms.

Service Area: Benzie County.

# 4. Homestead Dam Lamprey Barrier Public Fishing Site (MDNR)

One-mile long linear park, also known as the Homestead Dam Site, with canoe, kayak and boat launch, parking, spillway, and pit toilets. Open to the public along the north side of the river from the spillway to the US-31 access site.

Service Area: Benzie County, region, State of Michigan.

# 5. Betsie River Public Access Site (MDNR)

Less than 1 acre miniature park on the northeast side of the Grace Road crossing. The site has parking, pit toilets, and a canoe and kayak launch.

1/4 mile long linear park on the southeast side of the River Road crossing. The site has a canoe, kayak, and boat launch, fishing along the stream, and parking. Service Area: Benzie County, region, State of Michigan.

# 7. Betsie River Fishing Access Site (MDNR)

Easement running east off of US-31 to state property (1/4 mile long) along the south side of the river between Wallaker Road and US-31.

# 8. Vacation Trailer Park (Private)

Frontage on the Betsie River, located northwest of the US-31 bridge crossing of the Betsie River. The park has 100 tent and RV public campsites with electricity, sanitary dump station, pool, canoe rentals, sport shop, showers, and cabin rental.

# 9. Crystal Lake Golf Course (Private)

18-hole public course and driving range.

# 10. **Pinecroft Golf Course** (Private)

18-hole public course and driving range.

# 11. Benzie-Manistee Tribal Outpost and Community Center (Grand Traverse

Band of Ottawa and Chippewa Indians) -80 acre site with a community center for health and social services and a residential complex.

Service Area: For tribal members residing in Benzie and Manistee Counties. *Accessibility Assessment - 3* 

# 12. **Sagaser Nature Preserve** (Grand Traverse Regional Land Conservancy)

20 acre wooded area with nature trails.

Service Area: Benzie County, region.

# 13. **Trapp Farm Nature Preserve** (Grand Traverse Regional Land Conservancy)

Located east of the Village of Beulah with access from US-31, Narrow Gauge Road, and Eldridge Road. 115 acres of wetlands with 2000 feet of tributaries of the Cold Creek, with nature trials, boardwalk, and parking off Narrow Gauge Road.

Service Area: Benzie County, region.

#### 14. Dead Stream Road Crossing of Dead Stream (MDNR)

Access site for canoe and kayak launching and fishing.

Access from Lake Street, which runs north of Platte Road.

Canoe, kayak, and small boat usage. The Betsie River is designated a Natural Wild and Scenic River that runs from Grass Lake to Betsie Lake and into Lake Michigan.

# 17. **Betsie Valley Trail** (MDNR/Benzie County)

Located on the former Ann Arbor Railroad right-of-way north from

Thompsonville to Elberta and Frankfort.

# 18. Betsie River Public Access (MDNR)

Northeast of where US-31 crosses the Betsie River. The site includes parking, pit toilets, and trails.

# 19. Platte River Water Trail

Canoe and kayak route.

Service Area: Benzie County, State of Michigan.

# 20. Commercial Forest Reserve Acreage (Private)

Open to the public for hunting and fishing. Note: Status of CFR properties is subject to change.

a. Betty Hastingsb. Luman and Olga Wilcox60 acres230 acres

c. Luman and Olga Wilcox 71 acres (North of US-31 only)

# 21. Proposed Scenic Corridor (NPS)

Proposed to run along the top of the ridge between Big Platte Lake and Crystal Lake from M-22 near the intersection with Platte Road to US-31 north of the intersection with Lincoln Road.

#### 22. **Zada Price Park** (Benzie County/Benzie County Road Commission)

Five-acre community park, also known as Mitchell Park or the Wilson Property, located on the north side of Crystal Lake near the marina. The area has shoreline access for swimming, and provides for launching of canoes, kayaks, and light boats (road-end within frontage). Ample off-road parking across Crystal Drive. Snowmobile and ice-fishing access to Crystal Lake in the winter.

# 23. Railroad Point Natural Area (Benzie County)

66 acres of wooded steep bluffs and hills on Railroad Point, with a nature trail, 2700 feet of frontage on Crystal Lake and the Betsie Valley Trail, and a parking area off of Mollineaux Road at the south end of the parcel. Included in the management of Railroad Point is the Benzie County Crystal Lake Park (See No. 28) which is owned by the Benzie County Road Commission and leased to the Benzie County Board of Commissioners for park purposes only and which is managed as a part of the Railroad Point Natural Area as a part of the long-range

plan. A non-motorized trail provides access from the Railroad Point Natural Area to the Benzie County Crystal Lake Park.

# 24. Proposed Public Boating Access Site on Crystal Lake (MDNR)

The site will be the only MDNR access site on Crystal Lake. Planned with 38 paved car-trailer parking spaces, 20 paved companion car spaces and unpaved overflow parking, two double-ramps with filtration, and ADA accessible. Located on M-115 between Frankfort and Benzonia at the east end of Mollineaux Road

One of the last drive-in movie theaters in Michigan. Located on Honor Highway (US-31) south of Honor.

# 28. Benzie County Crystal Lake Park (Benzie County)

320 feet of Crystal Lake Frontage, 13 acres of hilly and wooded land area, surrounded with no development. Owned by the Benzie County Road Commission and leased to the Benzie County Board of Commissioners, it was deeded to the County with restrictions that it be used for park purposes only. It is managed as a natural area in conjunction with the Railroad Point Natural Area (See No. 23) and is accessed by a non-motorized trail from the Railroad Point Natural Area. It is located in Section 21, T26N-R14W.

# Blaine Township

#### 1. Blaine Township Hall and Park (Blaine Township)

Offices and a large multipurpose room with a one acre community park. Includes open space at the end and south side of White Owl Road on Lower Herring Lake. The park is adjacent to the County road-end at Herring Lake with a parking area, picnic tables, and a shelter.

Service Area: Blaine Township.

# 2. Lower Herring Lake Public Access Site (MDNR)

Boat launch, dock, swimming, and parking.

# 3. **Upper Herring Lake Preserve** (Grand Traverse Regional Land Conservancy)

Large mural in the Frankfort Post Office depicting a historic car ferry on Lake Michigan in a storm.

## 25. City Hall (City of Frankfort)

Recently rebuilt offices and meeting space located on Main Street.

# **Planning Methods**

The method of planning used for this Master Plan was the Systems Approach to Planning (MDNR, 2006). The Systems Approach is a three part planning method: examine the information already available; collect public input; and develop goals and objectives based on areas of need from public input and the existing information. This is one of the recommended planning methods by the Michigan Department of Natural Resources.

The first step in the Systems Approach planning process was to conduct accurate inventories to determine what recreational and cultural facilities already existed in Benzie County. A lengthy process was used to ensure the inventories were comprehensive and complete. First, all township, village, and city supervisors in Benzie County were interviewed. The information gathered from the local officials was compared with the existing inventories from the 1992, 1997, and 2002 Recreation Master Plans. A meeting was then held where members of the Parks and Recreation Commission reviewed all of the inventory data that had been collected to ensure accuracy. Benzie County residents involved with recreational and cultural activities were also consulted to verify existing entities and accuracy of information collected. Eventually, a thorough and accurate inventory was produced after compiling all of the data.

The second step in the planning process was to gather public input. Several methods of gathering public input were utilized: survey; public input session; historical review; and monthly meetings. A survey was mailed to 2000 residents in Benzie County. A thorough analysis of the data collected is available in Chapter Five of this plan. A public input session was held at the Mill's Community House on October 27, 2008. The results of this meeting are included in Chapter Five and the Documentation section of this plan. Public input was also analyzed from the 1992, 1997, and 2002 Recreation Plans, as well as the Benzie County 2020 Comprehensive Plan. Additionally, the PRC received public input during their monthly scheduled meetings at the Benzie County Government Center.

The final step in the planning process was to reconcile the inventories with the feedback collected from the numerous opportunities for public input. This was performed in order to develop an effective set of goals and objectives that accurately reflect the needs of Benzie County residents and visitors, while not duplicating the existing facilities and services of the County. By using this Systems Approach, the PRC is confident that their goals, objectives, and action strategies accurately reflect the needs of Benzie County residents and visitors.

# **Public Input Process**

In order to collect public opinion for this plan, two different methods were used. The first one was a mailed survey. The second method was a public information session held at the Mills Community House in the Village of Benzonia on October 27, 2008. Additionally, other plans such as the 1992, 1997, and 2002 Benzie County Recreation Master Plans, and the Benzie County 2020 Comprehensive Plan were used to gather public input as well.

The first method used to collect public opinion was a mailed survey. In July of 2008, 2000 surveys were mailed out to residents of Benzie County. The sample was determined by a method of systematic random sampling. First, a list of all property owners in Benzie County was obtained from the Benzie County Equalization Department. To ensure that all respondents were people who actually lived in Benzie County, any property owners who lived outside of the county were deleted from the list. This left approximately 6000 names on the list. Next, every name was assigned number one, two, or three; the first name on the list was assigned a number one, the second name was assigned number two, and so forth. All of the names assigned a number one or two were then deleted. This resulted in a final sample size of 2000 people. It can be assumed that 1 out of 3 owner occupied households in Benzie County received a survey.

Of the 2000 surveys that were distributed, 213 were returned, resulting in a response rate of about 10%. The timeframe for responses was originally set four weeks from the time the surveys were mailed out; this was later extended to allow for two extra weeks to maximize the response rate. There were 10 questions on the survey, including both close-ended and open-ended questions. The seven close-ended questions were formulated to collect demographic information and to find out what recreational and cultural facilities and programs residents of Benzie County currently use. The three open-ended questions were provided to allow respondents an opportunity to list any new programs or facilities they would like to see added in Benzie County in the future.

# **Survey Responses**

Question one of the survey asked the ages of the members of the respondent's household. The responses to this question were skewed toward older adults (See Graph 5-1). This could be explained by assuming that older adults have more free time to fill out surveys, or that more, older adults could be homeowners in Benzie County than younger adults.

Question two asked how many members of each gender were in the respondent's household. The responses were almost completely even, with slightly more females than males (See Graph 5-2).

Question three asked what governmental unit (township, city, or village) respondents lived in. The largest portion of respondents lived in Almira, Benzonia, and Lake Townships (See Graph 5-3). The rest of the responses were somewhat evenly distributed across the rest of the governmental units in Benzie County.

Question four asked respondents what recreational areas were most used by members of their households (See Graph 5-4). This question was designed so that respondents could only select their top five choices. The choices that were selected most frequently were beaches, natural areas, non-motorized trails, picnic areas, and playgrounds. The rest of the responses were evenly spread out across the other options (See Graph 3-4).

Question five asked respondents what cultural facilities were most used by members of their household. They were asked to only select their top five choices. The results were somewhat inconclusive, with responses spread out across all of the possible responses (with the exception of dance studios). The top two responses were museums and historic buildings/sites, respectively (See Graph 5-5). These responses were followed closely by sports venues, visual and performing arts venues, art galleries, and training/education facilities, respectively.

Question six asked respondents what recreational activities members of their households participated in. This question was asked so that respondents could select as many choices as applicable. The top responses, in order, were walking/hiking, swimming, fishing, and canoeing/kayaking (See Graphs 5-6a & 5-6b).

Question seven asked respondents what cultural activities members of their households participated in. The activities most participated in are visiting historical building/sites, watching music performances, visiting art and historical museums, and arts and crafts, respectively (See Graph 5-7).

Questions eight through 10 were open-ended. They were formulated to ask survey respondents what facilities and programs they would like to see added in Benzie County.

Question eight asked specifically about recreational areas and facilities that respondents wanted to see added in Benzie County. As can occur when a question is asked in an openended format, a variety of responses were received. Most of the responses concerned the Betsie Valley Trail and/or trails in general: extending the trail; paving unpaved parts of the trail; clearing snow from the trail so it can be used for jogging in the winter; adding non-motorized trails for walking and hiking; and adding more motorized trails for ATVs

and ORVs. Other high frequency responses included a public swimming pool and an ice rink (See the Documentation Chapter for a copy of all responses received).

Question nine asked residents what new recreational programs and/or services they would like to see added in Benzie County. The top two responses were organized swimming programs and facilities to accommodate water activities. Other popular responses were libraries, community sports with lessons, and improved access to existing activities. A number of respondents did not answer this question. There are a couple of possible explanations for this. One explanation could be the question was worded in a way that was unclear or confusing to respondents. Another possible explanation could be survey respondents may be happy with the current recreational programs or services in the county (See the Documentation Chapter for a copy of all responses received).

Question 10 asked Benzie County residents what cultural activities and facilities they would like to see added or improved in Benzie County. The most popular responses were increased support for public libraries and more performance (musical, theatrical, etc.) venues. Other popular responses included more educational opportunities, increased access to historical sights and museums, and public meeting space. Some respondents said that they did not want any changes, that Benzie County already has enough of the programs and facilities (See the Documentation Chapter for a copy of all responses received).

# **Public Input Session**

On October 27, 2008, a public input session was held at the Mill's Community House in the Village of Benzonia. The purpose of this session was to gather public input about the direction of the Recreational and Cultural Master Plan. In all, 35 Benzie County residents attended the session. A variety of topics were discussed, among them were the need to pave more of the Betsie Valley Trail, the need for more public meeting and performance space, and the need for more educational opportunities in Benzie County. A complete synopsis of the meeting is available in the Documentation Chapter of this plan.

Additional public input was received at the September Parks and Recreation Commission meeting. One Benzie County resident voiced concerns about the lack of areas for skateboarding in the County. He said that the County needs more areas for young people to ride their skateboards safely.

# Goals, Objectives, and Action Plan Priorities

<u>Goal 1</u>: Benzie County will have an active County Recreation Commission that promotes recreational and cultural opportunities for citizens, seasonal residents, and transient visitors.

# Objectives:

- Maintain the Parks and Recreation Commission as established by the County Commission.
- Complete periodic updates of the County Recreational and Cultural Plan.
- Involve the citizens in recreational and cultural planning so that a wide variety of recreational needs are met.
- Work with State and Federal agencies to provide input on public lands management planning on behalf of County residents.
- Promote recreation and culture as a contributor to the improvement of quality of life and economic welfare.
- Increase County participation in coordination, management, and guidance of all recreational and cultural activities, particularly in the areas of initial placement.
- Identify facility deficiencies throughout the County and work with communities to develop projects to meet those needs.
- The Benzie County Board of Commissioners will see value in the role of the Parks and Recreation Commission and allocate an appropriate working budget.

#### Action Plan Priority:

Integrate Cultural Facilities and Activities into Recreational Planning
Integrate cultural planning (history, arts, and libraries) as a part of the total
recreation picture in Benzie County. Cultural opportunities are essential to a
community's overall quality of life, whereby they enrich lives, strengthen
communities, stimulate economic growth, enhance education, and, in general,
ensure lives are more active, productive, inspired, and enjoyable.
The value to Benzie County citizens is evidenced by the enthusiasm exhibited for
the arts, history, and libraries and level of participation in a variety of indoor and
outdoor activities. The area is rich with cultural organizations, facilities, schools,
historical sites, and a mixture of many cultural heritages. The Parks and
Recreation Commission recognizes the logic and benefit of integrating "cultural
tourism" with "recreational tourism" in developing and promoting Benzie County
as a destination point in Michigan.

<u>Goal 2</u>: Benzie County will consolidate all County owned recreational and cultural opportunities under the Parks and Recreation Commission. *Objectives:* 

- Work cooperatively with the Betsie Valley Trail Management Council to structure management levels within Benzie County government for the entire trail system in Benzie County, including existing and proposed connector links.
- Include a representative from all units of local government within Benzie County that have a rail-trail in their jurisdiction in the management of the trail system.

- Work cooperatively with the Friends of the Point Betsie Lighthouse to structure management levels under the Parks and Recreation Commission.
- Obtain funding for and hire a County Parks Manager.
- Actively manage Railroad Point for recreational access, environmental education and resource stewardship in accordance with the conservation easement held by the Grand Traverse Regional Land Conservancy.

#### Action Plan Priorities:

# • <u>Coordinate Recreational Activities and Programming</u>

Coordinated recreational activities and programming are vital to an improved quality of life for Benzie County citizens. Therefore, it is a priority for the Benzie County Parks and Recreation Commission. Support staff, including a Parks Manager, and collaborations with area organizations and individuals will be sought. This will encourage the community to become more involved with the Parks and Recreation Commission and each other to provide increased cultural and recreational programs and projects in the County.

NOTE: i.e. City, Villages, Townships, Grand Traverse Band of Ottawa and Chippewa Indians, National Park Service, Department of Natural Resources, Michigan State University Extension, Benzie Area Symphony Orchestra, Benzie County Players, Benzie Community Chorus, Benzie Community Band, Legacy Art Park, Crystal Lake Art Center, Mills Community House, Congregational Summer Assembly, Benzie Area Historical Museum, Garden Theater, etc. Also, nearby Interlochen Arts Academy, Dennos Museum, Ramsdell Theater, Little River Band of Ottawa Indians and other neighbors.

# • Consolidate Management of County Owned Properties

The Parks and Recreation Commission sees both the rail-trails (linear parks) and the Point Betsie Lighthouse and grounds as significant recreational resources held by the County and should be directly involved in their management.

#### NOTE: COUNTY AND REGIONAL PARKS, Act 261 of 1965

AN ACT to authorize the creation and to prescribe the powers and duties of county and regional parks and recreation commissions; and to prescribe the powers and duties of county boards of commissioners with respect to county and regional parks and recreation commissions.

46.351 County parks and recreation commission; creation; membership; terms; vacancy; commission as county agency; rules and regulations; compensation.

46.362 County and regional commissions; control and management of property

Sec. 12. A county or regional commission shall have the custody control and management of all real and personal property acquired by the county or a regional commission for public parks, preserves, parkways, playgrounds, recreational centers, wildlife areas, lands reserved for flood conditions for impounding: 46.358 County and regional commissions; acquisition of property

Sec. 8. A county commission may acquire in the name of the county and a regional commission may acquire in its name by gift, purchase, lease, agreement, or otherwise, in fee or with conditions, suitable real property, within the county or region, or contiguous with or adjacent thereto, for public parks, preserves, parkways, playgrounds, recreation centers, wildlife areas, lands reserved for flood conditions for impounding runoff water, and other conservation purposes. In acquiring or accepting land, due consideration shall be given to its scenic, historic, archaeologic, recreational, or other special features.

## • Completion of the Elberta Beach to Beach Trail Section

Work with the Village of Elberta, The Betsie Valley Trailway Management council, and the Friends of the Betsie Valley Trail to complete the Beach to Beach Trail Segment.

#### Parking for Visitors to the Point Betsie Lighthouse

Work with the Benzie County Road Commission and the Friends of the Point Betsie Lighthouse non-profit group to satisfy the parking needs at the lighthouse and conduct an engineering and right of way study for improvements to the roadend.

# • Thompsonville to Interlochen Trail Connection

The State Trailway Plan calls for looping, interconnection, and connecting communities with trails. The Thompsonville-Interlochen Rail Trail connection is currently being studied by an ad hoc stakeholder group with the support of the Benzie County Parks and Recreation Commission, the Betsie Valley Trailway Management Council, and the Traverse Area Rail Trail, Inc. The group has established that the initiative is both a local and State goal. The State Trailways Division of the MDNR has successfully obtained two major Natural Resources Trust Fund grants to purchase portions of the former Pere Marquette Railroad Corridor from private property owners from Kaleva north to within two miles of Thompsonville, and is working cooperatively with the Benzie-Manistee Snowbirds (snowmobile organization) on another segment. The only known obstacle is finding willing sellers for the 4-5 miles of remaining rail corridor not currently under State ownership in Manistee and Benzie Counties. Alternative routes may be necessary and easier to acquire.

• Northwest Michigan Regional Non-Motorized Transportation Plan and Investment Strategy 2008

The Northwest Michigan Council of Governments developed the plan for the 13 counties of Emmet, Charlevoix, Antrim, Kalkaska, Grand Traverse, Leelanau, Benzie, Manistee, Wexford, Missaukee, along with Osceola, Lake, and Mason in northwest, lower Michigan. The Michigan Department of Transportation commissioned the plan and will use it to prioritize funding projects for the future. The guiding vision of this project is to connect existing trails, offering residents and visitors more opportunities for non-motorized transportation, and to enjoy more of the region's natural resources. Benzie County Priority Routes:

- 1. Thompsonville to Bendon to Traverse City, 2. Honor to Betsie Valley Trail,
- 3. Complete route around Crystal Lake, 4. Complete route around Platte Lake.
- Archive Parks and Recreation Records and Project Files
   Not having the necessary support staff, the Benzie County Parks and Recreation
   Commissioners need to gather and organize all historical records and pertinent
   documents and place in the custody of the Benzie County Clerk.

<u>Goal 3</u>: Benzie County will increase access to all public lands and waters. *Objectives:* 

- Increase access to public lands for citizens and visitors.
- Increase access to all public waterways in Benzie County for swimming, fishing, and boating, including all appropriate types of watercraft i.e. motorized and/or non-motorized.
- Encourage the acquisition of lands for water access on lakes, rivers, and streams.
- The Benzie County Planning Commission and local jurisdictions will refine comprehensive plans for each jurisdiction that establishes appropriate locations for access sites.

- The Benzie County Planning Commission, the Recreation Commission, the Road Commission, the Department of Natural Resources and local jurisdictions will develop adequate public launch sites with off-street parking, buffered from adjacent properties.
- Preserve water access through road-ends.
- The Benzie County Recreation Commission will partner with local interest groups to develop educational programs for persons who fish and boat regarding safety, invasive species control, shoreline and near-shore habitat protection, and private property rights.

#### Action Plan Priorities:

#### • Access to Public Waters

Access to various water activities is a major concern to Benzie County residents and visitors. Public access is not sufficient and there are often conflicts between riparians and the general public. Many access sites are not improved to provide off-road parking and paved launch ramps. Given that water access is important to various recreational activities that are attractive to both Benzie County citizens and visitors it has remained a top priority for more than a decade. The Benzie County Parks and Recreation Commission will work collaboratively with the National Park Service, MDNR, the Benzie County Road Commission, Townships, City of Frankfort, and Villages to preserve public access at road-ends and to provide improved public boating access to waterbodies.

# MDNR Crystal Lake Public Boating Access Site

The <u>Public Trust Doctrine</u> in Michigan declares, "The Department of Natural Resources is the caretaker of our natural resources, charged by the legislature with the duties of acquiring, conserving, and developing for public use, the natural resources of the State, including access to water."

The resolution that formed the Benzie County Parks and Recreation Commission declares, "Whereas the recreation and water resources section of the Master Plan will be impacted by future events that will require a government structure for adequate response" and "That its purpose will be that of implementing the goals and objectives relating to recreation and water resources in Benzie County." Therefore, we, the Benzie County Parks and Recreation Commission, continue to stand firmly in support of the planned and permitted MDNR public access site on the south shore of Crystal Lake, and resoundingly believe the Courts should approve construction to proceed as soon as possible for the safety and welfare of our citizens.

## • Comprehensive State Statute Re: Access to Public Waters

The Benzie County Parks and Recreation Commission affirms the public's legal right and desire to fish, boat, and sail on Michigan's inland lakes and reemphasizes the legality and importance of access to lakes and streams if all citizens are to enjoy those public resources. After enduring years of costly delays and litigation over a single access site in the County, the Benzie County Parks and Recreation Commission recognizes the need and supports a comprehensive state statute or constitutional amendment that clearly and firmly establishes for all time the public's right of access to our inland lakes and streams.

#### Access to Public Lands

The Parks and Recreation Commission will advocate and provide for continued and appropriate access to public lands for the use of county residents and visitors alike. Public lands remain invaluable to both residents and visitors for recreational activities ranging from a hike or leisurely drive, to use for hunting and fishing, to an even more active ride down a trail on a horse or snowmobile. Access must be maintained and/or gained to many public lands, also, to lakes and streams via roads and trails owned by the County Road Commission, GTRLC, the Department of Natural Resources, and the National Park Service.

<u>Goal 4</u>: The Benzie County shoreline of Lake Michigan will provide recreational opportunities for all Benzie County citizens and visitors.

#### Objectives:

- Recognize the Lake Michigan shoreline as an open space that can be used by all citizens and preserved for public use.
- Provide Lake Michigan access sites at regular intervals along the County shoreline
- Provide sufficient parking and other related facilities at access sites.
- Maintain Lake Michigan beaches in excellent condition.

#### Action Plan Priority:

<u>Lake Michigan Drive Road-end Access Improvement</u>

The Platte Bay fishery is a world-class fishery without a viable launch facility. The project is for the complete reconstruction of the existing access site on Lake Michigan Drive at the mouth of the Platte River on Platte Bay.

The current ramp is made of old bomber mat that is now rusted out and breaking up with unsafe jagged protrusions. The Benzie County Parks and Recreation Commission, the Benzie County Road Commission, Lake Township, the National Park Service, the Department of Natural Resources, the State Waterways Commission (grant funding), and the Grand Traverse Band of Ottawa and Chippewa Indians (grant funding) all understand the launch facility is in very poor repair and the need for the reconstruction project is both important and immediate. There are serious concerns about boater safety that this project will solve, and we look forward to seeing those anglers that no longer fish Platte Bay return.

<u>Goal 5</u>: Benzie County will expand recreational and cultural offerings for persons with disabilities.

# Objectives:

- Promote recreational opportunities for particular population groups such as the elderly; physically, mentally, socially or economically handicapped; youth and others that require special attention.
- Increase access for persons with disabilities to all waterways through accessible boat ramps and docks.

#### Action Plan Priority:

Expand Recreational Opportunities to Include Persons with Disabilities
 Coordinate with the Trailway Management Council and the Department of Natural Resources to pave the Betsie Valley Trail from Beulah to Mollineaux Road. This will allow safe use by disabled citizens and visitors, and discourage pedestrian traffic on the narrow roadway adjacent to the trail.

<u>Goal 6</u>: Benzie County will have a wide variety of indoor and outdoor recreational and cultural opportunities for citizens, including school-age children, seasonal residents, and transient visitors.

## Objectives:

- The County Recreational and Cultural Plan is periodically updated to meet the needs of citizens and to upgrade or obtain parks, recreational, and cultural facilities not provided by schools.
- Encourage the development of additional year-round, indoor and outdoor recreational and cultural facilities that correct deficiencies in the County's inventory of facilities.
- Develop County recreation properties for appropriate recreational and cultural uses.
- Encourage rehabilitation of historic structures for public recreational and cultural uses.
- Meet the recreational needs of residents in communities throughout the County who enjoy parks, playgrounds, ice rinks, tennis courts, basketball courts, skateparks, and ballfields in sufficient numbers at various sites throughout the County.
- Encourage innovative approaches and techniques to meet local recreational and cultural programs and facility needs.
- Encourage the private sector to develop facilities that will complement public uses.
- Promote access to trails, parks, and public lands for non-motorized uses such as walking, hiking, biking, roller-blading, skateboarding, and cross-country skiing.
- Increase lands for hunting.
- Encourage access to snowmobile trails and list roadways and/or trails open for ORV use.
- Recognize school-supplied recreation as a key component of the total County recreation system.
- Benzie County communities work in conjunction with the schools to provide
  access to schools for recreational and cultural opportunities and encourage the
  school system to "open their doors" to community organizations to better utilize
  meeting rooms, auditoriums and theaters, gymnasiums and locker rooms, and
  other outdoor recreational facilities.
- Strengthen and provide educational outreach in Benzie County by encouraging community based educational opportunities by groups such as the Michigan Department of Natural Resources, 4H, and other university and extracurricular programs.

- Promote public safety through good planning and programs in Benzie County in collaboration with schools, clubs, and other organized efforts.
- Assist libraries desiring a countywide library system in Benzie County.
- Support the development of scenic roadways that are integrated with other recreational uses.

#### Action Plan Priorities:

# • Preservation of Natural Resources

Benzie County's landscape has a north-woods character. It is a unique combination of forests, wetlands, orchards, fields, hills, valleys, dunes, high bluffs, beaches, and clear lakes and streams. Benzie County citizens and officials believe this character is so important to the economy of the County and well being of its citizens that they made open space and natural resource preservation a major goal of the Benzie County 2020 Master Plan. Without a serious effort by government and individual citizens, Benzie County's north woods landscape character will be compromised.

# • M-22 Scenic Heritage Route and Bikeways

The M-22 scenic corridor project is a priority of the Benzie County Parks and Recreation Commission. This corridor is a designated Great Lakes Circle Tour Route and primary north-south scenic corridor located in western Benzie County adjacent to the Sleeping Bear Dunes National Lakeshore, Platte Lakes, Crystal Lake, and Lake Michigan that links north and south parts of Benzie County to Frankfort. It crosses the Platte River and traverses the resort areas of Crystal Lake and scenic rural pastoral landscapes with many tree-lined roads and spectacular viewsheds. In Leelanau County, our neighbor to the north, M-22 is now a designated Scenic Heritage Route and scheduled for work within the Sleeping Bear Dunes National Lakeshore for a separate non-motorized pathway developed by the NPS. In addition, Leelanau County's Parks and Recreation Plan calls for development of bikeways along the M-22 corridor to connect with Benzie County.

• Forestry Management Plan Projects and Railroad Point Enhancements
As stewards of Benzie County park lands, sustainable forestry will be utilized to
maintain: recreational access, species and habitat diversity, forest age class
diversity and health in consultation with a licensed forester. Timber management
at Railroad Point Natural Area will be in accordance with the timber management
plan approved by the Grand Traverse Regional Land Conservancy that holds the
conservation easement. Forest management activity at Railroad Point Natural
Area will be conducted with the consent of the Grand Traverse Regional Land
Conservancy.

<u>Goal 7</u>: Benzie County will continue to have numerous opportunities for hunting and fishing.

#### Objectives:

• Encourage open space and natural habitat preservation on private lands by private landowners.

- Develop a program for public or conservation organization purchase of open space and other wildlife habitat lands or easements, as well as improved opportunities for public access to water.
- Develop an education program for owners of open space or wildlife habitat on the benefits of property donation or conservation easement and seek donations of properties on the list of desired recreation sites.
- Preserve the use of State and Federal lands for hunting and fishing.
- Develop educational programs for persons who hunt, fish, and boat regarding safety, invasive species control, shoreline and near-shore habitat protection and private property rights.

Action Plan Priority: (See Goal 8)

<u>Goal 8</u>: Benzie County will increase access to information regarding recreational and cultural opportunities in the county, and will promote Benzie County as one of Michigan's valued recreational and cultural destinations.

#### *Objectives:*

- Create a Parks and Recreation web page as part of the Benzie County Government web site.
- Work with the Benzie County Chamber of Commerce, the Benzie County
  Tourist and Visitors Bureau, the Cultural Organizations Collaborative, the Grand
  Traverse Regional Land Conservancy, the Michigan Department of Natural
  Resources, the National Park Service, etc. to link their websites with the new
  Parks and Recreation page.

## Action Plan Priority:

<u>Create a Parks and Recreation Web Page</u>
 Include the recreational and cultural inventories from the 2009 Master Plan on the website to educate people about the existing recreational and cultural entities in Benzie County. Also, provide links on the web page to existing informational websites for maps showing hiking trails, equestrian trails, snowmobile trails, hunting land, conservancy land, etc.

<u>Goal 9</u>: Recreational properties in Benzie County will be good neighbors with other land uses.

#### *Objectives:*

- Locate recreational uses so as to minimize conflict with adjacent landowners and the environment while maximizing the benefit of the site.
- Buffer, whenever possible, recreational uses from conflicting land uses with setbacks and/or vegetation.
- Encourage the development of recreation/resort complexes only under planned unit development procedures.

Action Plan Priorities: (See Goal 10)

<u>Goal 10</u>: Benzie County anticipates future recreational and cultural needs and will act on opportunities for the acquisition and development of recreational and cultural facilities, sites, open spaces, and programs.

## Objectives:

- Benzie County will encourage the development of recreational uses in locations attractive to citizens and tourists.
- Identify priority sites to purchase for recreational purposes.
- Acquisition of land should be prioritized to address the most popular recreational
  activities as identified from public input, including walking/hiking, swimming,
  fishing, canoe/kayaking, and wildlife viewing.
- Link recreational land acquisitions with other natural resource protection
  priorities including the M-22 and Betsie Valley Trail scenic corridors, inland
  lake access, rare or endangered habitats and species, scenic vistas, cultural
  resources, and State-designated environmental areas such as Critical Dunes,
  Natural Rivers, and State Game areas.
- Collaborate with public and private partners, including the Grand Traverse Regional Land Conservancy, to fund the purchase and maintenance of recreational properties and market these recreational opportunities to the public.
- Develop an education program for owners of potential recreational properties on the benefits of property donation and seek donations of properties on the list of desired recreational sites.
- Encourage the utilization, for recreational uses, of lands that have soil types that are less conducive to "developed" uses, i.e. agriculture, residential, commercial, or industrial
- Promote recreational uses that do not infringe upon the visual or ecological quality of open spaces, forests, hills, bluffs, orchards, lakes, shorelines, or embankments, but enhances or at least preserves, the natural quality that creates the original need or desire for a facility in that area.
- Preserve floodplain areas and wetlands for open space activities, such as wildlife refuges, hunting, fishing, and passive recreation.
- Considering demand, encourage the development of a system whereby the number of participants is controlled at acceptable levels in sensitive areas to diminish impacts on natural resources.
- Encourage the creation of tourism related jobs for County residents to increase economic growth.

#### Action Plan Priorities:

#### • Collaborate with Public and Private Partners

Take advantage of land acquisition opportunities that support the highest priorities for recreational activities as identified by the public survey, including the acquisition of land for public beaches, natural areas, and for extension or enhancement of non-motorized trails (including the Betsie Valley Trail). Acquisition opportunities will be carefully considered to insure that the site is compatible with its intended uses and that the site can be legally and safely accessed by the public.

• Work in Cooperation with Local Units of Government

The Benzie County Parks and Recreation Commission will encourage each community in the County to develop or upgrade its Recreation Plan.

The Commission will encourage local communities to work with the County Planning Commission, local planning commissions, and the County Parks and Recreation Commission to assess the need for facilities, methods to acquire, fund and develop projects, and the responsible operation and maintenance of same.

Please note that some of the information included in the above goals and objectives was taken from the 1992, 1997, and 2002 Benzie County Recreation Plans and the 2020 Benzie County Comprehensive Development Plan.

# Synopsis of the October 27, 2008 Public Information Session

# Benzie County Planning and Parks and Recreation Commissions Joint Meeting

This document is a synopsis of the Public Information Session held at the Mill's Community House on October 27, 2008. The names of most respondents were withheld to protect their privacy. The approved minutes are on file in the Benzie County Clerk's office and are available to the public.

PRC Chairman Tanner called the meeting to order at 7:04 p.m.

Mr. Tanner greeted the people and explained the purpose of the meeting.

Planning Commission Chairwoman Kathy Ralston thanked the Parks and Recreation Commission for hosting the joint meeting.

The floor was given to County Planner, Dave Neiger. Mr. Neiger greeted the public encouraging all to turn in scorecards for the Grand Vision. He then spoke on the importance of the plan in developing County resources. At that point he introduced Syrus Bingman, consultant, and turned the meeting over to him.

Syrus Bingman explained the information that had already been gathered through the mailed survey. He stated there was a 10% return rate in the survey, which is a very good return for a survey. He then asked the public for their ideas and what they see for the future.

#### Visions:

Some kayakers would like to see restrooms along the Betsie Valley Trail at the Betsie River.

There is interest in seeing an ice skating rink, maybe in a community center with a swimming pool included.

One respondent would like to see an educational task setting group set up.

One respondent voiced interest in seeing a 4-H horse area built. This idea was furthered by people thinking a Horse Show Ground could be incorporated into a Community Center. There were also suggestions of a horse trail possibly running parallel to the Betsie Valley Trail.

One respondent stated a recreational center would be great as there is a need for something like that for young people. Possibly something like a YMCA.

One respondent spoke on a continuing education site. Some feel Benzie County Central High School would be a good site for both adult and college educational courses. It was stated that Frankfort High School has funds for this type of programming.

A school board member stated that Baker College is willing to come up to BCCHS and do classes. This has been discussed at the school.

One respondent stated that the Betsie Valley Trail people would like to see a plan to pave the rest of the trail. It was stated that the CLPRA is under agreement that the trail section can't be paved unless it is approved by a majority of property owners. Further discussion stated there had been a settlement, but more residents may want it paved now. There was discussion that a trail extension from Benzie County into Grand Traverse County was being planned. Dave Neiger explained there is only about one mile of property left to purchase for expanding the trail to Karlin.

A former trail-coordinator for the BVT said if all parties agree to the paving on the Beulah to Mollineaux section, it can be done with a coordinated effort.

Further statements were that there are a lot of diverse interests and we need one hub to manage all the projects and organizations. Concerns were voiced that this could be setting a stage for competition on projects. There was a suggestion for getting a parks and recreational department head to manage county activities so that we don't compete for funding.

One respondent informed the group that BCHS has a set of plans and is looking for a piece of property and funding for an ice hockey rink.

The retiring director reported on the Point Betsie Lighthouse. She stated the volunteer friends group needed help covering its expanded use.

One respondent would love to see a place for performing arts in the County.

One respondent from the National Park Service explained the plans for improvements in the National Park. There is a non-motorized trail in the works paralleling M-22 for Leelanau County. It would be great if it could continue along M-22 in Benzie County.

One respondent spoke on the need for coordination of an arts center, possibly including culinary arts and dance. She also suggested a swimming pool and spoke on the renovation of the Frankfort Coast Guard Station.

One respondent stated that Grow Benzie has purchased the green houses and buildings along M-115 for the future use of Grow Benzie.

One respondent supported the idea of a recreational center listing multi-uses like a swimming pool, weight training, and ice rink as being needed.

Don Tanner explained the status of the Crystal Lake boat launch issue. One person voiced caution about putting access on the lake.

One respondent informed all that the Mills Community House has things in place for improvements and expansion. He told of the library offering a children's hour the last Saturday of the month. The Mills is trying to set programming so that they are open more.

It was stated that one Benzie County resident has a collection of maritime memorabilia. He needs a place to put the collection.

Ann Bourne explained how the plan was written and its affect on project funding. Ann compared the money that the original plans have brought to Benzie County. None of this money would have been available without the plan. State organizations have encouraged communities to do cultural plans for the same reason.

One respondent suggested the County Web site needs to list places to see and things to do in the County.

Meeting adjourned at 8:35 p.m.








